

## **Splash Zone Tickets - Read All The Way To The End**

It's that time of year again! Charleston County Parks has contacted me to let me know that the water park tickets will be available again this year for Legacy Home School Group to sell.

*A little background:* These tickets that Legacy sells are not the "Splash Passes" for the entire summer. The Splash Passes are sold through Charleston County Parks and Recreation. These tickets that are being sold through Legacy Homeschool Group are sold individually, the price is per person, per individual water park. These tickets are offered at a drastically reduced rate from the regular admission price. You can purchase as many tickets as you would like, to as many parks as you would like throughout the entire summer. They are available to purchase through Labor Day.

***Non-Refundable.*** I will not be able to refund any money for unused tickets. Legacy does not make any profit from the sales of these tickets; we are just a way that Charleston County Parks gets them out to the public, all money goes straight to Charleston County.

The parks are open from 10am-6pm on the weekends beginning May 4th through Labor Day, Sept. 2nd. Beginning May 27th, the water parks are open (same hours: 10am-6pm) daily through mid August. From mid August, the parks are again open only on the weekends until Labor Day, Sept.2nd. Labor Day is the last day the parks are open.

### ***Ticket prices are as follows -***

Mt. Pleasant, Palmetto Islands County Park

***(Splash Island):*** \$4.99/ticket

James Island, James Island County Park

***(Splash Zone):***\$7.99/ticket

North Charleston, Wannamaker County Park

***(Whirlin' Waters):*** \$13.99/ticket

***\*\* Children 2 and under are free & prices above are the same regardless of age or how many you buy.***

***\*\*You will still need to pay the Main Gate Admission to each park. The fee is \$1.00 per person... under 2 is free. So keep this in mind when you go.***
